January 11, 1911 - August 3, 2013

Dorothy E. (Weinbach) Lindenschmidt, age 102, of Evansville, passed away Saturday, August 3, 2013 at the Pine Haven Health and Rehabilitation Center.

Dorothy was a member of St. Agnes Catholic Church and a former member of both Christ the King and Holy Rosary Catholic churches. She was a third generation owner of Lindenschmidt Company and had also worked as a secretary for Bernardin Bottle Company.

“ Dear Carol, Jean, and Joe,

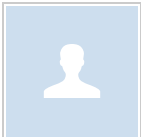
This is the second note I wrote. The first one came back with a message that I didn't type in my name and so I don't know if they let it go through or not.
